- **2.3 A full profile must be completed** to include address (or Box No.), contact details, qualifications, experience and services offered. You may include your own website address if you have one.
- **2.4** You are deemed to place a PI business listing with us by ordering via our online process.
- **2.5** Our acceptance of a listing **ONLY takes place** when we add your business listing to our website. We will send you a confirmation by email once we've added your listing.
- **2.6** We may refuse to accept a listing if it or the applicant does not meet any eligibility criteria set out in our terms and conditions.
- **2.7** By submitting your business details you agree we can contact you by email from time to time for client enquiries, marketing purposes or updating your profile.

3. PRIVACY POLICY
